. [5] "The record also shows that defendant was lawfully sentenced to the minimum term of two years. That was an authorized sentence under the Penal Code (§§ 3020, 3024) and under the ordinance. It was not a punishment or deterrent." (P. 616.) Section 3020 of the Penal Code provides in part: "When any person is convicted of any offense, except manslaughter, assault with intent to commit murder, assault with intent to commit rape, or assault with intent to commit robbery, under the provisions of this chapter it shall be the duty of the court to pronounce the judgment of conviction; and the court shall make such order in respect to the imprisonment and custody of such person as shall be just and proper under the circumstances of the particular case, and as such order may be appealed from, in the same manner and with like effect as any final judgment." Section 3024 of that code provides: "The punishment for a misdemeanor is a fine of not exceeding one thousand dollars (\$1,000) or by imprisonment in a county jail not exceeding one year or by both such fine and imprisonment. Evaluation of soyoebanoids, a group of biological products, for the prevention of surgical site infections. Surgically contaminated wounds create a risk of infection due to colonization of the surgical site with environmental bacterial species. To reduce or eliminate this risk of infection, we evaluated Surgisome (R) wound spray, an active agent device that may be applied to the wound after surgery, for its efficacy in reducing post-operative infection after surgery involving a contaminated wound. To prepare a clinical trial site, a University veterinary hospital was selected and the hospital personnel participated in the study. After acquiring institutional approval, informed consent was obtained from each volunteer. Prospective or retrospective clinical trials were established using volunteer dogs undergoing castration, ovariectomy, or exploratory abdominal surgery. A 2-second spray of Surgisome (R) was applied to the surgical wound. The wound was surgically prepared and closed. The patient was monitored for 30 days post-surgery. Six dogs were enrolled in the study. Four dogs were treated with surgical site preparation and closure using the Surgisome (R) spray and two dogs were treated without any intervention. Subcutaneous abscesses, granulation, and crust formation were observed between the 30th and 60th post-operative days. All of the abscesses were located on the side of the treated surgical wound.
